Summary and Deadlines from the Online working meeting SELID and EFOS 29. April 2021

Program of the meeting:

To the point:

- 1. Meeting in Dresden: After 45 minutes discussion, some proposals and comments, such as:
 - we can meet in Dresden personally and part of the participants, who cannot travel can participate virtually;
 - we can need green passport / card to be allowed to travel abroad or to enter country;
 - there is a problem with the cancelation of the rooms according to the cancelation policy for the group reservation it is minimum 40 days in advance and for individual reservation it is 5 days in advance.
 - Currently there are all restaurants and meeting rooms in Germany closed. It could cause the problems also in June;
 - the area of Saxony is the worst attacked in Germany,

we decided to propose new term for the transnational meeting in Dresden. It is September from 23 to 25. 9.2021 (22. September arrival, 23. – 24. September SELID transnational meeting, EFOS meeting, SELID Working seminar; 25. September Cultural visits).

<u>December 2021</u> Alicante (1.12. arrival, 2. – 3.12. project transnational meeting, working seminar, 4.12. Cultural visits)

March 2022 Magdeburg transnational project meeting SELID conference, EFOS meeting. Meeting in Brno is going to be canceled, because of time shortage. The final conference in Magdeburg was already agreed for March 2022, therefore there are not possibilities to have meeting in Brno instead of Magdeburg.

Mobilities, which have been planed for Brno, can be realized at other transnational meetings and 10% of the mobility budget can be used as it is described below.

3. COVID Amendment and its consequences:

Amendment has been signed by the rector of Comenius University in Bratislava and Slovak National Agency SAAIC for the Erasmus+ programs on 28. April 2021.

Amendment gives possibilities when we realised minimum one virtual project meeting:

- To move 10% from the budget part for management to the part of the Special costs (I see it not important, because Management is the lump sum (Pauschale) which has flexible usage)
- To move 10% from the budget part for the transnational meetings (mobilities) to the part of the Special costs.
- Special costs can be used only for 3 reasons: 1. for the renting the rooms, 2. for the costs for hardware or 3. for the software cost. For the documentation of usage, you need to have invoice to show how money has been used.
